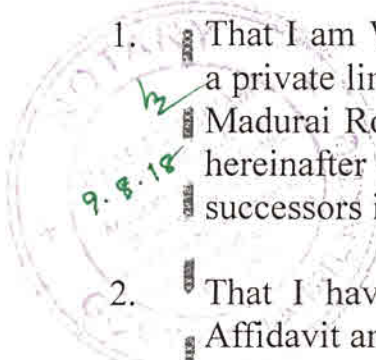

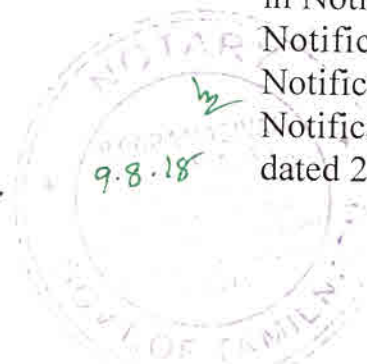
### AFFIDAVIT

7. I certify that the marks or words used in unbranded container are not registered by the Company under the Trade Marks Act, 1999 or any other law for the time being in force.
8. I, R.K.M.Rajkumar, the above-named deponent, do hereby verify that the contents of this affidavit are true and correct to the best of my knowledge, information and belief.

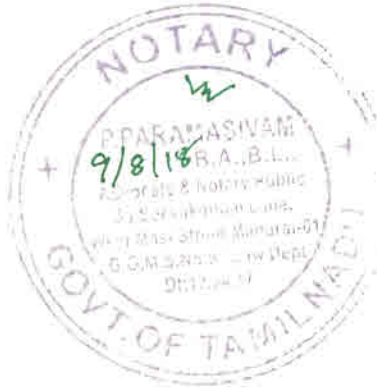
