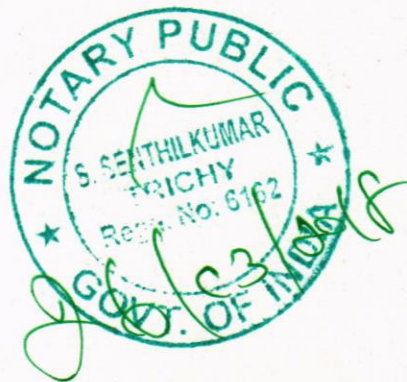

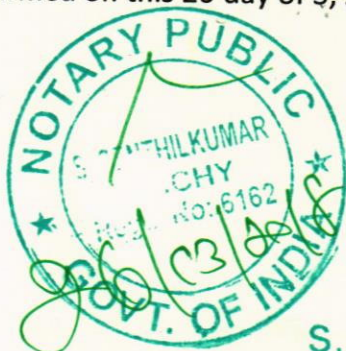
For this purpose I/we am/are filing this affidavit with the Commissioner of State Tax as required in the Annexure-I to the notification mentioned above.
