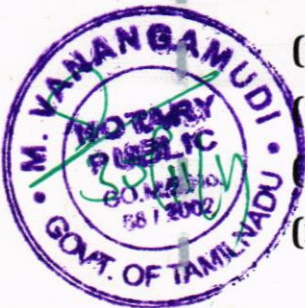

We also undertake that we will immediately give written information to the Commissioner of State Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
