



We have taken GST Registration for supply of rice and our registration number is 33AAGPR5483C1ZQ,

For our supply of rice, we wish to avail the exemption from SGST under the G.O. No. (Ms) NO.63 dated 29.06.2017 as amended by G.O. No. (Ms) NO.115 dated 1 22.09.2017 issued by the Government of Tamilnadu.

For this purpose I am filling this affidavit with the Commissioner of Central Tax as required in the Annexure-I to the notifications mentioned above.

We are voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.

We further undertake that we shall, on each unit container of rice, clearly print in indelible ink both in English and the local language that we have voluntarily forgone our actionable claim and enforceable rights in respect of the brand names printed on the unit containers.

We also undertake that we will immediately give written information to the Commissioner of Central Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
