AFFIDAVIT

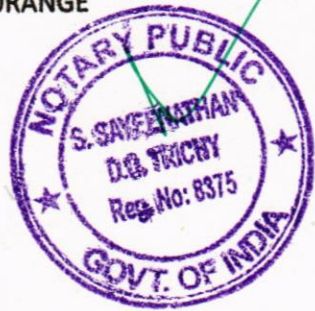

For this purpose I am filing this affidavit with the Commissioner of State Tax as required in the Annexure-I to the notification mentioned above.

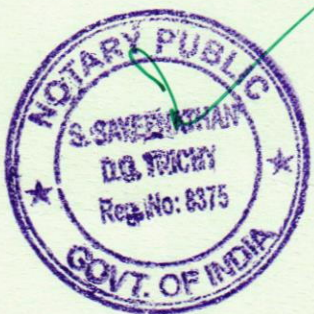
I am voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.
