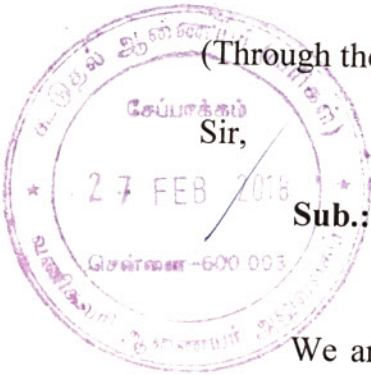

I/We request you to take the Affidavit on record and accept the same.

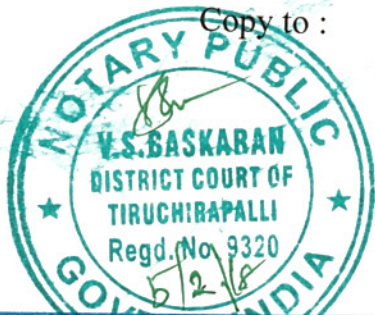

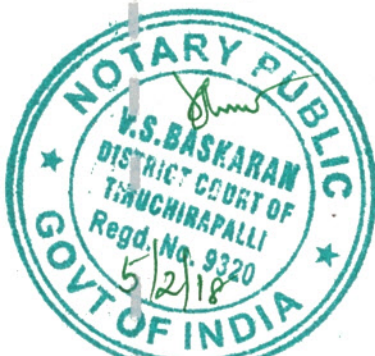

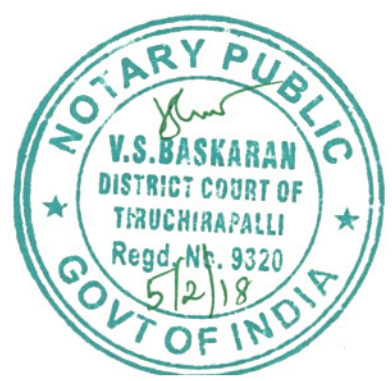
