- 2. The Company runs a super market in Madurai at No. Door No.9A, TPK Road, Palanganatham, Madurai - 625 003 (Branch Office) and supply groceries, rice, pulses and grams etc. The GST registration number of the Company is 33AAOCA7551P172

3. As the Company engaged in business as supermarket, it procures groceries, rice, pulses and grams etc. packs them to supply to its customers. Groceries,

rice, pulses and grams etc. are packed and supplied to the customers in unit containers bearing brand name 'Alagendra's'. As the brand name was not registered, the goods (hereinafter referred to as 'specified goods") dealt with in SI. Nos. 27, 29, 45, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 77, 78, 101 and 108 of Govt. Order (Ms) No.63 dated June 29, 2017 issued by Commercial Tax and Registration Department (B1), Govt. of Tamil Nadu and of Notification No. 2/2017 – Central Tax (Rate) dated June 28, 2017. (herein after referred to as "Exemption Govt. Order /Notification"), supply in unit containers were exempted under the "Exemption Govt. Order/Notification" until there were amendments made in the said "Exemption Govt. Order/Notification" with effect from September 22, 2017.

- 4. The brand name mentioned in para 3 above, is not a registered brand name under the Trade Mark and Merchandise Act, 1999 or Copy Right Act, 1957 or any other law for the time being in force in any other country as on 15.05.2017 or anytime thereafter until now.
- 5. The Company understand from the amendments made to "Exemption Govt. Order/ Notification "through Govt. Order (Ms) No. 115 issued by Commercial Taxes and Registration Department (B1) and through Notification No. 28/2017 Central Tax (Rate) both dated September 22, 2017 respectively (hereinafter referred to as "Amending Govt. Order/Notification"), that the specified goods are now taxable, even if these specified goods are put up in unit containers which is bearing a brand name, unless the conditions specified under Annexure I to "Amending Govt. Order/Notification" are complied.
- Therefore, in order to avail the exemption of both CGST and SGST, under "Exemption Govt.
 Order/Notification", as amended by "Amending Govt. Order/ Notification", the company submit
 this affidavit pursuant to the said "Amending Govt. Order/ Notification" to state that
 - a. The Company are voluntarily forgoing our actionable claim and enforceable right on our brand name mentioned in para 3 above.
 - b. The Company further undertake on each such unit containers, clearly print in indelible ink both in English and the local language that the company have voluntarily forgone our actionable claim or enforceable rights in respect of the brand name printed on the unit containers.

The Company also undertake to give written information immediately to the Jurisdictional Commissioner of State Tax/Central Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our packing of groceries, rice, pulses and grams.
