For our supply of rice, we wish to avail the CGST exemption under Notification No.2/2017-C.T (Rate) dated 28.06.2017 as awarded by the Notification No.28 / 2017 C-T (Rate) dated 22.09.2017 issued by the Government of India.

For our supply of rice, we also wish to avail IGST exemption under Notification No.2/2017-I T (Rate) dated 28.06.2017 as awarded by the Notification No.28/2017-I T (Rate) dated 22.09.2017 issued by the Government of India.

For this purpose I/We am/are filing this affidavit with the Commissioner of Central Tax as required in the Annexure - I to the notifications mentioned above.
