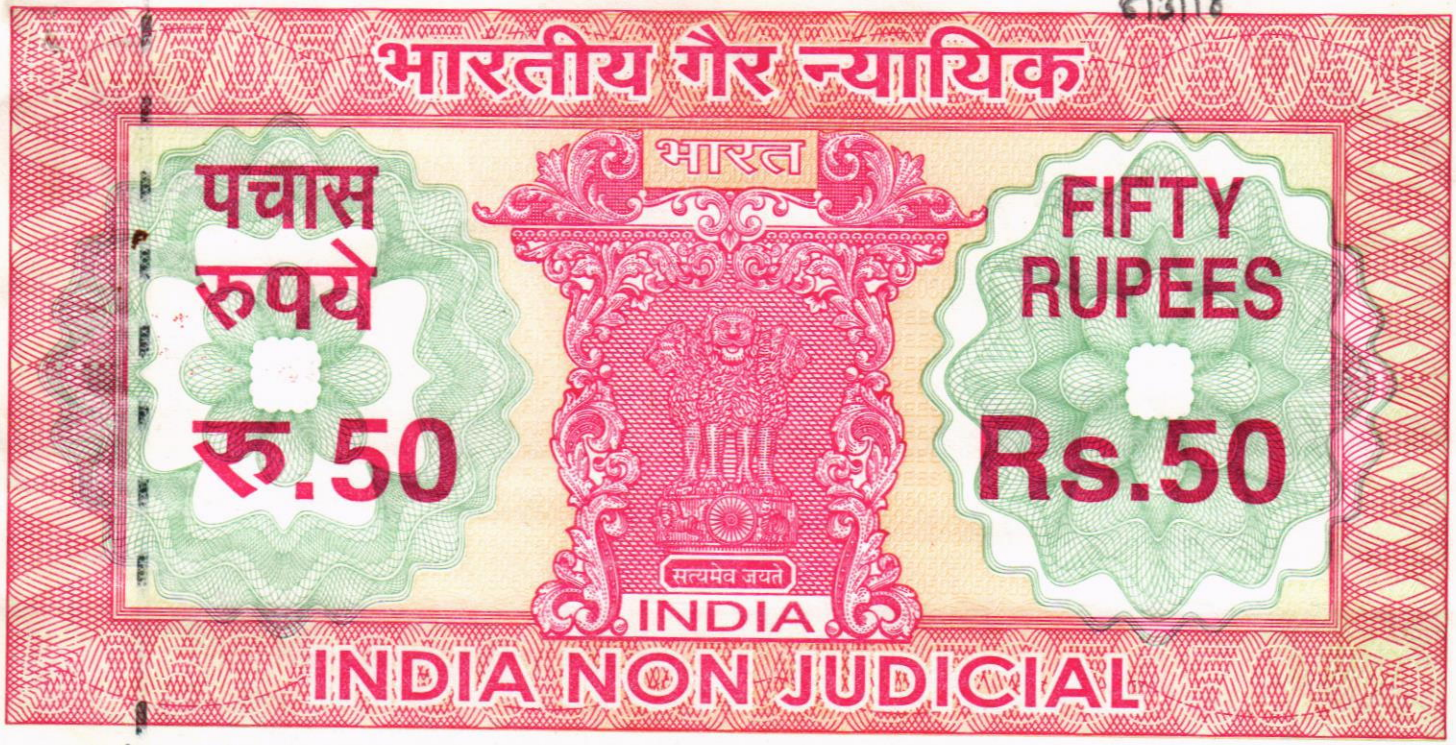

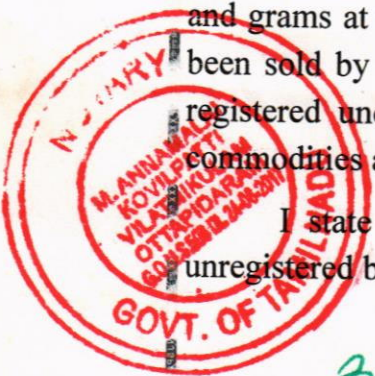
**AFFIDAVIT**

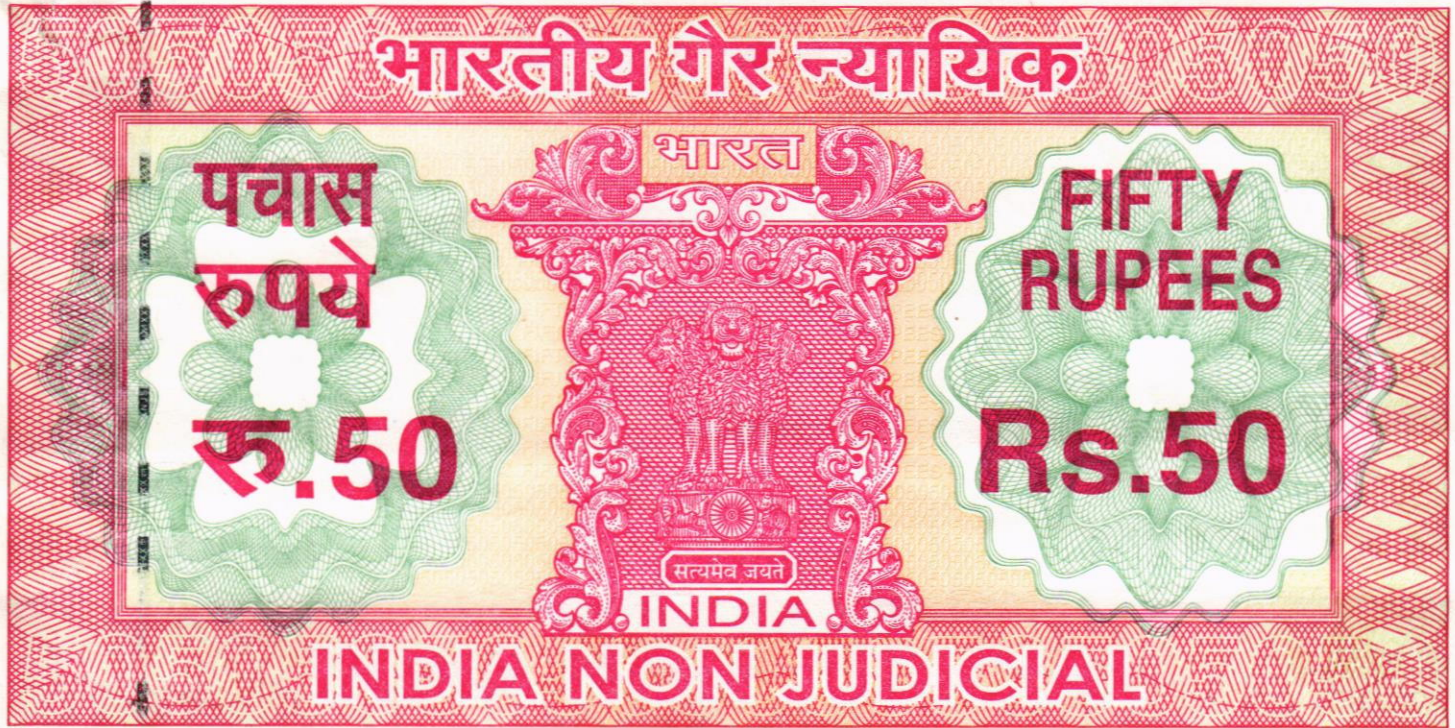

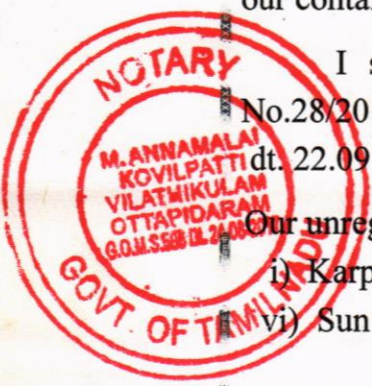
