We have taken GST registration for supply of rice and our registration Number is 33AAVCS9492E1ZO.

For our supply of rice we wish to avail the GST exemption under G.O.No.(MS) No 63 dated 29.06.2017, as amended by G.O.No. (MS) No.115 dated 22.09.2017 issued by the Government of Tamilnadu.
