For this purpose, we are submitting herewith an affidavit, as registered in the Annexure-I to the notifications mentioned above,

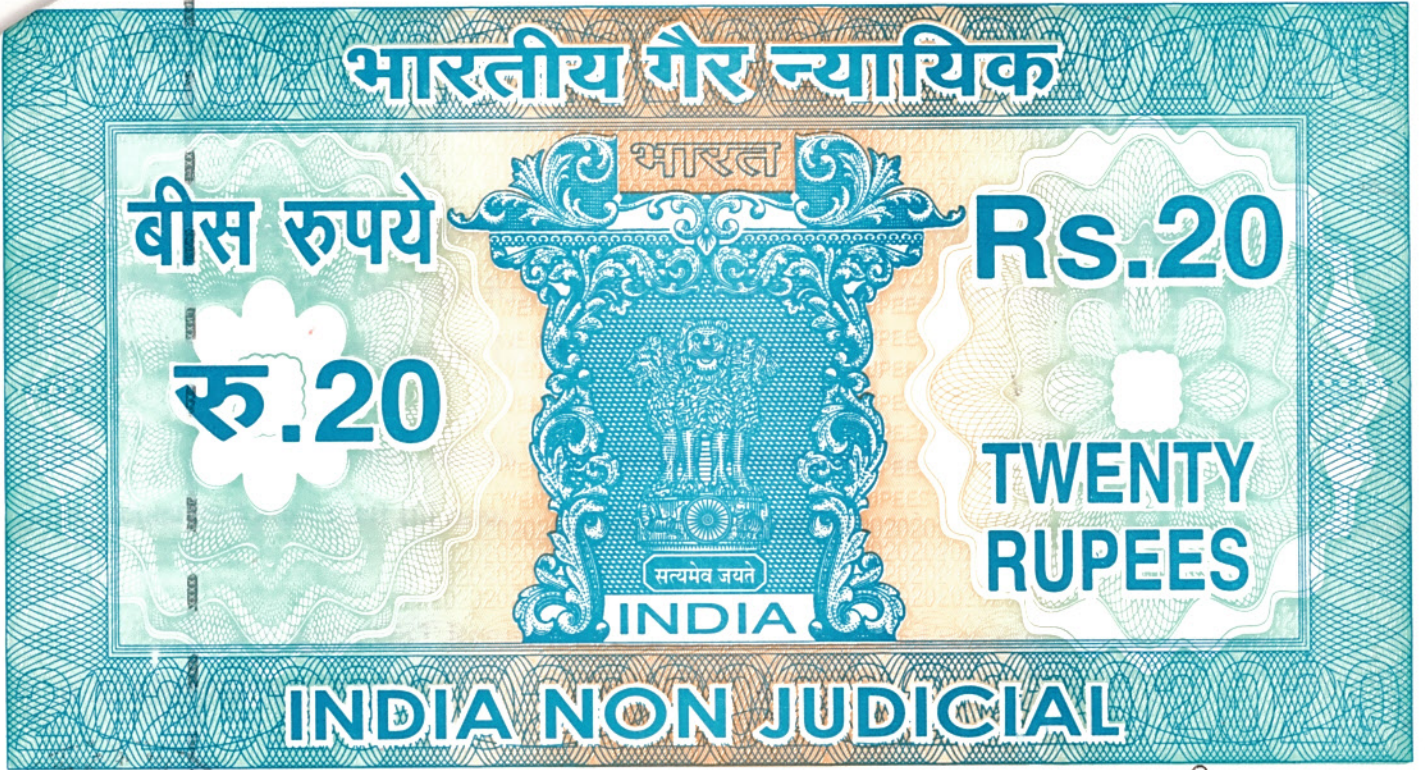

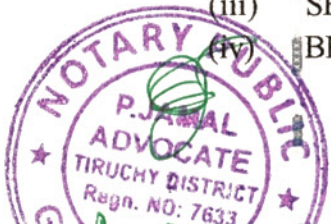

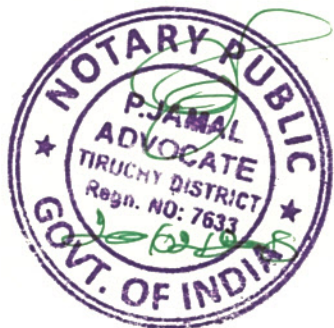
