For this purpose I/We am/are filling this affidavit with the Commissioner of State Tax as required in the Annexure-I to the notifications mentioned above.

We are voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.

We further undertake that we shall, on each container of rice, clearly print in indelible ink both in English and the local language that we have voluntarily forgone our actionable claim and enforceable rights in respect of the brand names printed on the unit containers.

We also undertake that we will immediately give written information to the Commissioner of State Tax about any fact and circumstances that will have a being on the applicability of the exemption to our supply of rice.
