I am voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.

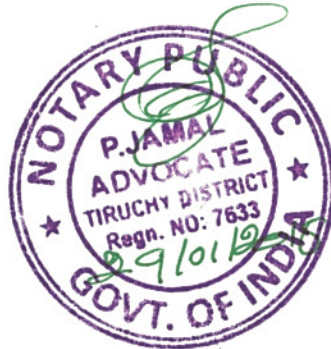
I also undertake that I will immediately give written information to the commissioner of central tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
