We have taken GST Registration for supply of rice and our registration number is **33ALMPT2270L1ZP**.

For our supply of rice, we wish to avail the CGST exemption under Notification No. 2/2017- C.T (Rate) dated 28.06.2017, as amended by Notification No. 28/2017 - C.T. (Rate) Dated 22.09.2017 issued by the Government of India.

For our supply of rice, we also wish to avail IGST exemption under Notification No. 2/2017- I.T (Rate) dated 28.06.2017, as amended by Notification No. 28/2017 - I.T. (Rate) Dated 22.09.2017 issued by the Government of India.

We also undertake that we will immediately give written information to the commissioner of Central Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
