

I/We am/are proprietor/partner/director of <u>PROPRIETOR</u>, which is located at <u>Theerampalayam</u>, <u>Azhaiyamanavalam Post</u>, <u>Thiruvarangapatti Road</u>, <u>Mannachanallur Taluk</u>, <u>Trichy District 621005</u>, I/We am/are engaged in the business of manufacturing/trading in rice.

I/We am/are supplying rice in packages bearing the following brand names

- (i) ANANTHAVINAYAGAR BRAND
- (ii) BELL BRAND
- (iii) VIP BRAND
- (iv) SEMPARUTHI BRAND





We have not registered the above – mentioned brand names under the Trade Marks act, 1999/ or copy Right Act, 1957/ or any law for the time being in force in any other country as on 15.05.2017 or thereafter.

The Above brand names were neither registered as on 15^{th} May 2017 nor registered after their till now.

We have taken GST Registration for supply of rice and our registration number is <u>33ALMPT2270L1ZP</u>.

For our supply of rice, we wish to avail the CGST exemption under Notification No. 2/2017- C.T (Rate) dated 28.06.2017, as amended by Notification No. 28/2017 - C.T. (Rate) Dated 22.09.2017 issued by the Government of India.

For our supply of rice, we also wish to avail IGST exemption under Notification No. 2/2017- I.T (Rate) dated 28.06.2017, as amended by Notification No. 28/2017 – I.T. (Rate) Dated 22.09.2017 issued by the Government of India.

For this purpose I /We am/are filling this affidavit with the commissioner of Central Tax as required in the Annexure – I to the notifications mentioned above.

We are voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.

We further undertake that we shall, on each unit container of rice, clearly print in indelible ink both in English and the local language that we have voluntarily forgone our actionable claim and enforceable rights in respect of the brand names printed on the unit containers.

We also undertake that we will immediately give written information to the commissioner of Central Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
