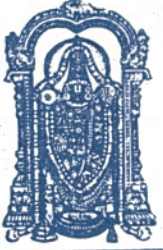

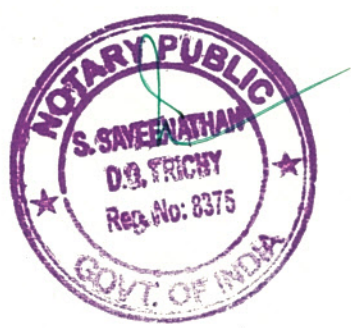
For this purpose I am filing this affidavit with the Commissioner of State Tax as required in the Annexure – I to the notifications mentioned above.
