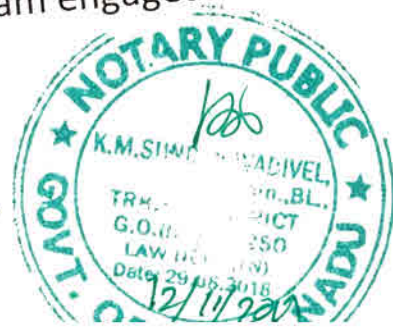


**AFFIDAVIT**
