We have taken GST Registration for supply of rice and our registration number is 33ATQPA7245J1ZJ.

For our supply rice we wish to avail the CGST exemption under Notification No. 2/2017 - C. T. (Rate) dated 28.06.2017, as amended by Notification No. 28/2017 - C. T (Rate) dated 22.09.2017 issued by the Government of Tamilnadu.

For our supply of rice we wish to avail the IGST exemption under Notification No. 2/2017 – I. T (Rate) dated 28.06.2017, as amended by Notification No.28/2017 – I. T (Rate) dated 22.09.2017 issued by the Government of Tamilnadu.

We are voluntarily forgoing our actionable claim and enforceable right on our brand-names mentioned above.

We also undertake that we will immediately give written information to the Commissioner Of State Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
