
We are suppliers of rice put-up in unit containers bearing unregistered brand names.

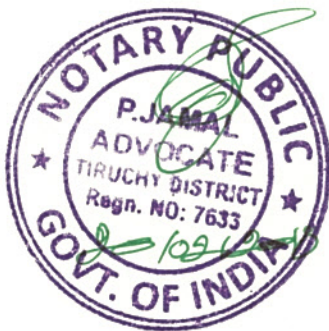
