Apart from the above manufacturing activites, we are trading the pulses and grams having brand/trade names like Shivani Gold, Baba Gold, M.Gold, Maharaja, Royal Samrat, Shivani Plus, VV Gold, Elephant, Baba Orange, Sunrise, Good Morning, Anchor, Baba Deluxe, Anmol Gold, Kamadenu, Nandhi, Narashima, Tiger, Gopi Gold, Yogi Brand, Annapoorna, Bhagavan, RC Premium, Kitchen Samrat, Coconut Tree, Deepam, Dug, Kamal, Seven Star, Anil, Welcome, Good luck, JSR, Thai, Sri, Idlesamrat, Chennai Express, Chennai Super, Vadaraja, JK, Surya, Deepak, Good day, India no.2, Angoor, Om, Balaji, Idly, Kajubadham, DVG, etc and also in our trade name. The above said brands are not registered anytime by their respective manufacturers under the Trade Mark Act, 1999 or any other law, Indian or Foreign, to protect the accrued Intellectual Property Rights. We have sold the said goods as such without adding fresh brand name but in our trade name only. The above commodities are exempted and classified under GST Act bearing HSN No.0713.

I state that we are conscious of the fact that we are not entitled to institute any proceeding to prevent or to recover damages for infringement of the Brand/Trade names used by us in the course of our business under the relevant provisions of the Trade Mark Act, 1999. We are also aware that by not registering the Brand/trade name under the Trade Mark Act, 1999, no IPR accrues on us and that no statutory protection is available to the Brand /trade names used by us. We have also not made any actionable claims or claimed any rights with respect to the unregistered Brand/trade names used by us in the past either on charges of infringement or passing off.
