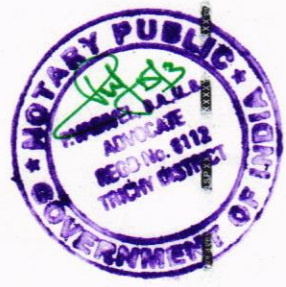


AFFIDAVIT

I am voluntarily forgoing our actionable claim and enforceable right on our brand names mentioned above.


