The above brand names were neither registered as on 15<sup>th</sup> may 2017 nor registered after their till now

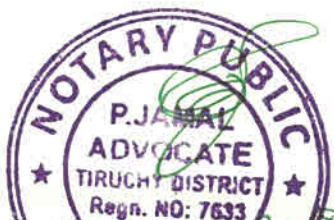
We have taken GST Registration for supply of rice and our registration number is **33DTJPK2932N1ZD**,
