We have not registered the above mentioned brand names under the Trade Marks Act, 1999/or Copy Rights Act, 1957/or any law for the time being in force in any other country as on 15.05.2017 or thereafter.

The above brand names were neither registered by us as on 15<sup>th</sup> May 2017nor registered after their till now.

We have taken GST registration for supply of rice and our registration Number is 33DWUPK8938J1ZM.

For our supply of rice we wish to avail the GST exemption under G.O.No.(MS) No 63 dated 29.06.2017, as amended by G.O.No. (MS) No.115 dated 22.09.2017 issued by the Government of Tamilnadu.

For this purpose I/We am/are filing this affidavit with the Commissioner of State Tax as required in the Annexure-I to the Notifications mentioned above.

We also undertake that we will immediately give written information to the Commissioner of Central Tax about any fact and circumstances that will have a bearing on the applicability of the exemption to our supply of rice.
