2	Air compressor	Taxable at 4% capital goods and Part B under entry 25 of I Schedule
3	Textile testing equipments and computers	Taxable at 12.5% under entry 69 of Part C of I Schedule
4	Electrical Transformers	Taxable at 4% under entry 141 of Part B of I Schedule
5	Electrical panel boards	Taxable at 12.5% under entry 69 of Part C of I Schedule
6	Electrical equipments and switches	Taxable at 12.5% under entry 69 of Part C of I Schedule
7	Electrical cables	Taxable at 12.5% under entry 69 of Part C of I Schedule

8	Electrical power generator	Taxable at 12.5% under entry 39 of Part C of I Schedule
9 10	Electrical motors Electrical spares	Taxable at 12.5% under entry 27 of Part C of I Schedule
11	Bearing	Taxable at 4% under entry 12 of Part B of I Schedule
12	Belting	Taxable at 4% under entry 16 of Part B of I Schedule
13	Tools	Taxable at 4% under entry 138 of Part B of I Schedule
14	Dies	Taxable at 12.5% under entry 69 of Part C of I Schedule
15	Die castings	Taxable at 4% Declared goods under entry 41 of Part B of I Schedule
