ORDER

Tvl. Ram Auto, No.9-A, New Agraharam, Dindigul – 624 001 (TIN: 33825200635) have filed an application and sought clarification and advance ruling on the following under section 48-A of TNVAT Act, 2006, read with rule 12-A of TNVAT Rules, 2006.

2. They sought clarification on the following:

“ What is the present rate of entry tax on two wheelers due to change in VAT rate of tax from 12.5% to 14.5%”.

3. The issue has been examined in detail with reference to provisions of the TNVAT Act and Rules and ruling is given as under.

4. The Tamil Nadu Value Added Tax (Second Amendment) Act, 2011 came into force on 27.09.2011, by inserting a new section 48-A for the constitution of a State Level Authority for Clarification and Advance Ruling to clarify any point concerning the rate of tax.

5. The amendment by inserting a new section 48-A was made under Tamil Nadu Value Added Tax Act, 2006 and not under Tamil Nadu Entry of Motor Vehicles into Local Areas Act, 1990.

6. The ruling is that, the request of the applicant does not fall under the provisions contained in Section 48-A of TNVAT Act, 2006 and the applicant is therefore not eligible to seek clarification from the authority for Advance Ruling and Clarification, and the request is therefore not capable of compliance as provided under Section 48-A of TNVAT Act, 2006.
