ORDER

Tvl.Chemoil Adany (P) Ltd., D-34,Halls Road, Egmore, Chennai 600 008, (TIN: 33830542059) have filed an application and sought clarification under Section 48-A of the TNVAT Act, 2006, read with Rule 12-A of the TNVAT Rules, 2007.

2. They have sought clarification on the following item in column 4 of Form 'VV':

"Bunker Fuel-High speed diesel (MGO)".

3. The issue has been examined in detail with reference to the provisions of the TNVAT Act and Rules and ruling is given.

4. The Tamil Nadu Value Added Tax (Second Amendment) Act, 2011 came into force on 27.09.2011, inserting a new section 48-A for the constitution of a State Level Authority for Clarification and Advance Ruling to clarify any point concerning the rate of tax.

5. The applicants have sought clarification on the rate of tax on **"Bunker Fuel-High speed diesel (MGO)".**

6. It is seen from the product description given by the applicants that the product dealt by the applicants is nothing but High Speed Diesel Oil.

7. Entry 7 of the Second Schedule to the TNVAT Act, 2006 reads as follows:

High Speed Diesel Oil

8. The ruling therefore is that **High Speed Diesel Oil** is taxable at 21.43% to the Entry 7 of the Second Schedule under TNVAT Act 2006.


