ORDER

Tvl. Pioneer Jellice India Private Limited, No.23, vallabai Road, Chokkikulam, Madurai (TIN: 33205002320) have filed an application and sought clarification under section 48-A of TNVAT Act, 2006, read with rule 12-A of TNVAT Rules, 2007.

2. They sought clarification on the following item in column 4 of Form 'VV':

"Di-Calcium Phosphate- animal feed additive".

- 3. The issue has been examined in detail with reference to the provisions of TNVAT Act and Rules and clarification is given as under:
- 4. The Tamil Nadu Value Added Tax (Second Amendment) Act, 2011 came into force on 27.09.2011, by inserting a new section 48-A for the constitution of a State Level Authority for Clarification and Advance Ruling to clarify any point concerning the rate of tax.
- 5. The applicant sought clarification on the rate of tax on "Di-Calcium Phosphate- animal feed additive".
- 6. It is seen from the details furnished that the applicant manufactures animal feed additive / supplement from animal bones. These poultry/cattle feed supplements are rich in Phosphorus and

Calcium and used in the preparation of poultry feed as additive by poultry feed manufacturers.

7. Entry 5 of Part B to Fourth Schedule reads as follows:

Aquatic feed, poultry feed, cattle feed and animal feed including supplement concentrates and additives, wheat bran, de-oiled cake, grass, hay and straw.

- 8. Di-Calcium Phosphate animal feed additive used in the manufacture of animal feed therefore fits into the description given under the Entry 5 of Part B to Fourth Schedule.
- 9. Therefore the clarification is that sale of "Di-Calcium Phosphate-animal feed grade" sold by the applicant is exempted from tax as per Entry 5 of Part B to Fourth Schedule under TNVAT Act, 2006.
