2. The clarification was sought on the following in column 4 of Form VV;

"Pigments (Industrial Input)".

- 3. The issue has been examined in detail with reference to the provisions of the TNVAT Act and Rules and clarification is given as under.
- 4. Goods classified under Entry 67-A of Part B of the First Schedule to the Act, whether sold either by the manufacturer or by the trader, are taxable at 5%. Pigments are enumerated under Entry 67-A (ad) (i) as, "Pigments including water pigments and leather finishes".

5. The clarification therefore is that "Pigments" are taxable at 5 % under Entry 67-A (ad) (i) of Part B of the First Schedule to the TNVAT Act, 2006.
