#### **ORDER:-**

In the Government Order first read above, the Government have constituted the State Level Tax Payers Advisory Committee, to identify issues relating to day-to-day tax administration faced by Trade and Industries having impact on the whole of Tamil Nadu and recommend solutions to the Department/Government under the Chairmanship of the Commissioner of Commercial Taxes.

- In the letter second read above, the Principal Secretary/ 2. Commissioner of Commercial Taxes has stated that the existing State Level Tax Payers Advisory Committee was constituted in the Value Added Tax scenario. At present, the Tamil Nadu Value Added Tax Act, 2006, except the goods included in Entry 54 of the State List of the Seventh Schedule to the Constitution, was repealed and the Tamil Nadu Goods and Services Tax Act, 2017 came into effect with effect from 01.07.2017. All other Acts administered by the Commercial Taxes Department like Entertainments Tax, Luxury Tax, Betting Tax, Advertisements Tax were subsumed in the Goods and Services Tax Act. Moreover, the Commercial Taxes Department is looking after Service Tax matters also. In this scenario, trading community from various sectors paying taxes in respect of goods as well as services and therefore equal participation of the members belong to Goods and Services in the Committee is essential.
- 3. The Principal Secretary/Commissioner of Commercial Taxes has further stated that the purpose of the constitution and functioning of State Level Tax Payers Advisory Committee will be fulfilled only if the representatives from both Goods and Services sectors are included so as to get their views and also to address their genuine grievances. Hence, the

The Principal Secretary/Commissioner of Commercial Taxes has further recommended that as per G.O.Ms.No.30, Commercial Taxes and Registration (A2) Department, dated 04.03.2019, the nomenclature of the officers in the Commercial Taxes Department has been changed due to the reorganization of the Department in the light of the implementation of the Goods and Services Tax Act, 2017 and other changes and suggested that the nomenclature of the Ex-officio Members may also be changed as above, while reconstituting the State Level Tax Payers Advisory Committee.

- 4. The Principal Secretary/Commissioner of Commercial Taxes has also stated that, some of the functions of the Committee are not applicable in the present Goods and Services Tax taxation system and do not fall in line with the current scenario. Hence, the functions of the State Level Tax Payers Advisory Committee may be revised as follows:-
  - 1. To make suggestion to Government on Commercial Tax Administration including policies and procedures.
  - 2. To provide the perspective of dealers/tax payers in making Commercial Tax administration more tax payer friendly.
  - 3. To suggest ways to reduce tax evasion.
  - 4. To find ways and means to improve tax collections.
  - 5. To suggest ways to act against defaulters.
  - 6. To suggest measures for better compliance for minimization of disputes and for avoidance of profiteering.
  - 7. To suggest measures in order to reduce the compliance burden of the small and medium suppliers without adverse effect on revenue.
- 5. After careful examination of the recommendation of the Principal Secretary/Commissioner of Commercial Taxes the Government have decided to accept the same and order to re-constitute the State Level Tax Payers Advisory Committee as indicated below:-
